Board of Directors Meeting

Thursday, April 2nd, 2020

Meeting was called to order at 7:03 pm.

Meeting was held virtually, using Zoom Video Conferencing.

COVID-19: Financial Implications

- Donato was invited but could not attend due to a conflict
- Jeff provided an overview of Expected 2020 Expenses
 - \$50K in Equipment and Uniforms

- \$83K in Fixed Costs (\$13K is for Sept-Dec)
- \$133K in Total Costs that must be covered in 2020 Calendar Year.
- Additional \$25K in Pending Equipment Costs that are being held
- Jeff presented two scenarios for consideration

Scenario 1: Partial Season is played

- Families would cover Fixed Costs, Equipment Etc.
- Would only be reimbursed for games/practices that did not occur.

Scenario 2: No Season

- o GMBA would be responsible to return fees and offset expenses.
- Rep teams would cover expenses already consumed (Marden/BEC/PPA/NCCP Training etc..)
- Current Estimates would require GMBA to hold back ~83\$/player when returning fees to cover fixed costs.
- With Scenario 2, all options are on the table to offset expenses
- Suggestion was made to ask families to donate more/full fees back to GMBA
- Suggestion made to discuss options with bank, gov't loan programs
- Jeff identified that we could access \$50K GIC to offset Equipment Costs, and use 2021 Equipment Budget to pay pack the GIC.
- Action: Jeff/Donato to discuss options with Landlord

COVID19: House League Contingency

- Jim walked us through the House League Altered Start Date Scenarios document shared prior to the meeting.
- Heather: noted that general feedback from House League parents, is that they want to play even if the season is modified.
- Ian noted that the City of Toronto canceled all outdoor activates until June 30.
- Libby noted that she provided the alternate scenarios to the city and is waiting feedback on the options
- Was also noted that the city just laid off all casual workers, which may have an impact on when we can start back up, as this will likely include field maintenance teams

In Person Baseball Activities

Motion to continue with no in-person baseball activities across GMBA until May 1st,
 2020 brought forward by Jeff

Seconded by Richard Motion Carried

Rep Program

- Guidance from Ontario baseball is that all baseball activities are on hold until May 1st.
- OBA feedback is still pending.

ICBA Update

- ICBA still in discussion on what a partial season will look like & OBA feedback is still pending.
- Motion to adopt Baseball Ontario Player Code of Conduct put forward by Stefanie Seconded by Jim Motion Carried

Select Program:

- Both Hamilton East and Hamilton West Centers will be part of the loop.
- SWOBA will likely fold

Registration Update

- Currently at 1007 registrations (750 house league)
- 22 families on subsidies
- 11 with family rates
- 4 families on Payment plans
- 13U only has 49 Registrations.

Houseleague Playing Up Policy

- Motion to adopt GMBA House League Playing up Policy to be effective for the 2021 Season put forward by Jim
 - Seconded by: Kevin
 - **Motion Carried**
- 2020 requests will continue using the existing process

Houseleague Playing-up Requests

- One Player Request brought forward
- Adam confirmed that the Player only received his white hat in the Rally Cap program and has not demonstrated the skillset to play up.
- Request will not be approved.

Technical Update

• Action: Rob will connect with Marden to cancel all bookings through May 1st as all baseball operations on hold per baseball Ontario.

Eliminations

- Kitchener has a 5 Days cancellation policy.

No Updates

Update from the City of Guelph

- City is under state of emergency until April 30th
- GMBA is not an Essential Service and must abide by City Guidelines.

Photo Day

- Currently scheduled for May 24th.
- Adam highlighted that this event does generate money for GMBA (~\$6/HL Player)
- \$10 of the HL fees are for Photo Day, but historically actual costs was ~\$4/player
- Suggestion put forward to investigate moving Photo day to August.
- Action: Libby to connect with Edge on options for rescheduling / cancelling event.

Tournament Update

- Discussions are currently underway to decide if early May Tournament will be put on hold/cancelled.
- Sean to bring forward a recommendation by mid April
- Targeting to review each tournament at least 3 weeks prior to tournament date to assess if viable.
- Question raised on if cancelation period for Tournaments / Diamonds would be needed 30 days before.
- Suggested that we look to OBA for options to recover fees for tournament registrations

Rotary Funding

- Libby provided an update on Rotary clubs and their overall mission
- Would like to request support from the 4 different Rotary clubs operating in Guelph
 - Request process requires
 - Grant Application

- A Director to provide a overview of GMBA at a breakfast meeting
- Libby suggested asking for a lower amount to start, as would increase chances.
- Jim suggested we ask for equipment instead of Capital Updates, as could be used to offset equipment already purchased.

Sponsorship Update

- Approximately \$3000 in confirmed sponsorships
- No Sponsorship fees have been paid yet.
