## **Special Board of Directors Meeting**

Thursday, July 6th, 2020

Meeting was called to order at 9:02 pm. Meeting was held virtually, using Zoom Video Conferencing.

# **Approval of Agenda**

Moved by Sean. Seconded by Richard. Approved

#### **Declaration of Conflicts**

Adam noted that all members who are also Rep coaches/parents would have a conflict when reviewing fees associated with their own age group.

Was noted that as board members we will follow our policy Adam withdrew his concern.

## **Cash Flow Forecast**

Donato walked us through the Cash flow projection provided before the meeting. Items of note:

#### **Bank Balance**

- Line items are just the most recent transaction listed for reference
- Balance listed is as of July 1st.

## **Expected Payment**

- Koko Noted Expected refund for Select may not be required, outside of 300\$ for Bantam team
- Donato noted that we also owe \$15,000 to the Guelph Storm to cover 100 Game vouchers issues as part of the 50/50 draws.

- This is not listed in our projection as the Storm are ok with differing payment
- Ryan noted that the Storm vouchers could be used for next year as well, Tickets vouchers could still be sold to recoup this.

## **Expected Receipts**

- Dorechester Tournament refunded 3 teams, but board only paid for 2. Need to confirm with coaches if additional team registered directly.
- Receipts do not include the Sportzone Credits for 2019 & 2020. Credits were requested this week.
- Decision on cashing GIC to be differed to the end of the meeting

ACTION: Donato will confirm if Overdraft protection exists on the accounts.

# **Rep Fees**

Donato walked us through the Rep Fees breakdown provided and the underlining spreadsheets used to derive the fees.

### Items of note:

#### Diamonds

- Updated City Diamond Costs to be reflected Budgeted at 5% increase form 2019, but actually cam in at 2%
- Diamond Allotment per team was updated based on diamond availability
- Bantam/Midget at Joe Kaine, the rest are at class B diamonds
- Lights are not approved by City and were removed. If lights become available, usage will be charged directly to the team.
- Umpire fees updated to use only 2 umpires at Midget.

## Equipment

- Full equipment costs to be charged out to teams.
- Ball usage reduced from 4 Dozen to 2 Dozen, as away team must provide defensive balls. Assumes 2 new balls per game x 12 games (6 home, 6 away)
- Each team will have a minimum of 2 sets of catching gear 1 new and 1 used set.
- Pitching Machine and Generators are billed out with the assumption of 1 new pair purchased per year. This cost is split over 5 rep teams this year.
- Revised approach for budgeting Pitching Machine/Generator/Maintenance to be investigated for 2021 Budget Process, Existing model to remain for 2020
- Suggested by Sean that that a capital fee & repair fund be setup for these costs.

# Fixed Costs / Other Costs

• Refund process –a 75\$ fee for players requesting a refund, would be required to cover expenses already incurred.

- Adam noted that we should review our fee structure for 2021 Budget to try and reduce pass-through items such as clinics, coaching uniforms, catching gear, and training that are charged back to the teams anyway. Teams could budget and pay for them as needed.
- Update the cost structure to an average of 12 player per team (down from 13)
- Equalization Costs Removed for the 2020 as Midget teams no longer have the added diamond expenses.
- Rep Team fees average out to just over 53% of original Budgeted amounts.

## **Motions**

Motion: Board approved the redemption of the GIC at the end of its current term. Moved by Jeff, Seconded by Vicki Motion Carried.

Motion: Motion to amend the GMBA rep refund policy to add as \$75.00 charge by player Moved by Adam, Seconded by Stefanie Motion Carried.
